1. **407 Wyandotte Ave.** – **variance request for construction of a new garage to replace an existing, non-conforming garage.** Owner applicants are Collin Odden & Heather Curtis.
2. **352 W. Lane Avenue** – preliminary meeting to review variances for a proposed restaurant use in the existing convenient store that is in front of the former Holiday Inn on Lane Ave. Second floor event space and roof patios are also proposed.

Committee members will meet at the **Pride Center at 248 E. 11th Avenue**, unless otherwise directed. Parking is available but limited. Please enter the facility at the rear. The doors are always locked, but you may access the vestibule using the ADA push paddle. Once in the vestibule, press the buzzer to the right and someone will open the door. Please make sure that all variances are correctly identified and noted. There are 7 Zoning Committee members. As always, the public is welcome.

PLEASE NOTE that applicants that have received a vote at the Zoning Committee meeting will present at the next UAC meeting on **December 20, 2017**, where a vote will be taken by the entire Commission. An agenda for that meeting will be sent later. The results of the UAC vote and a written recommendation will be forwarded to the Columbus Board of Zoning Appeals (BZA), or City Council, or Graphics Commission, as appropriate to each applicant's case.
